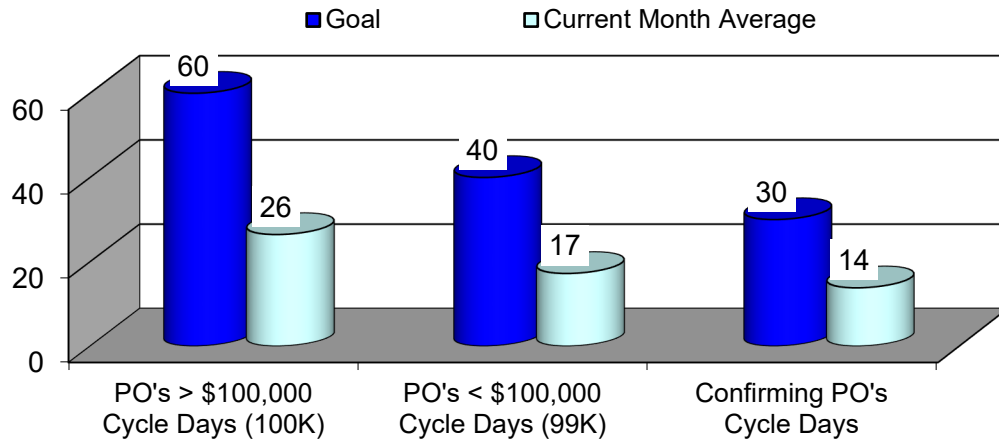




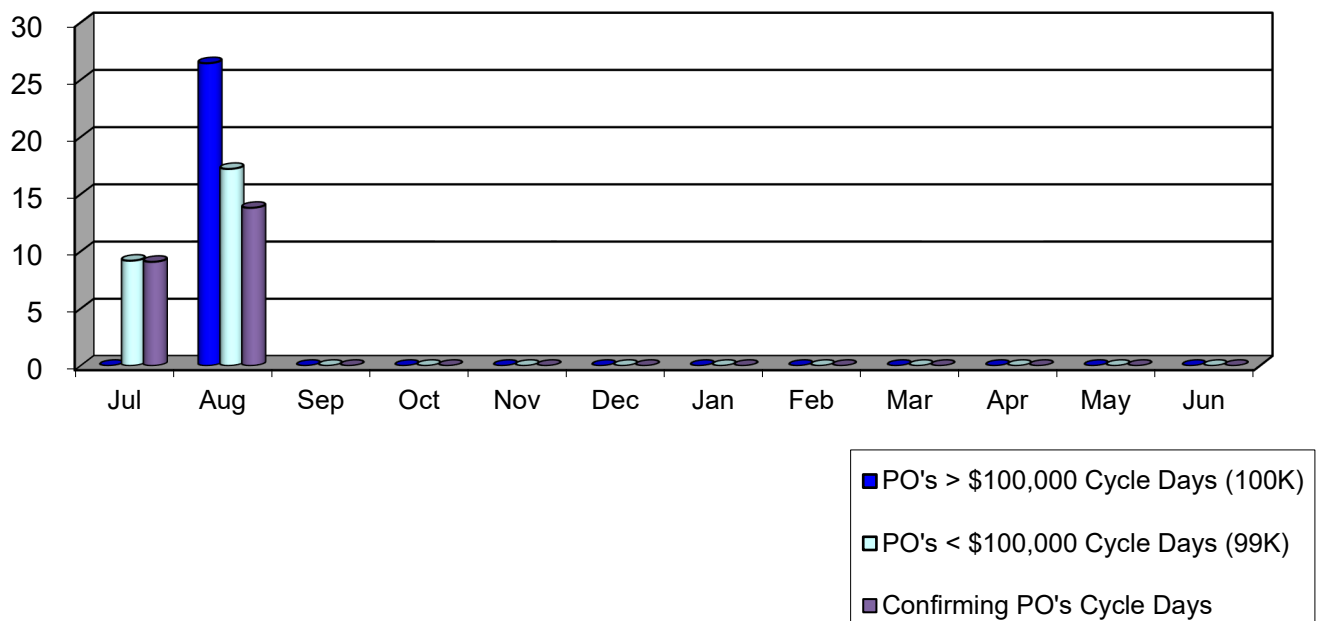




### Cycle Time for Requisitions Assigned to PO Award Current Month vs. Goal

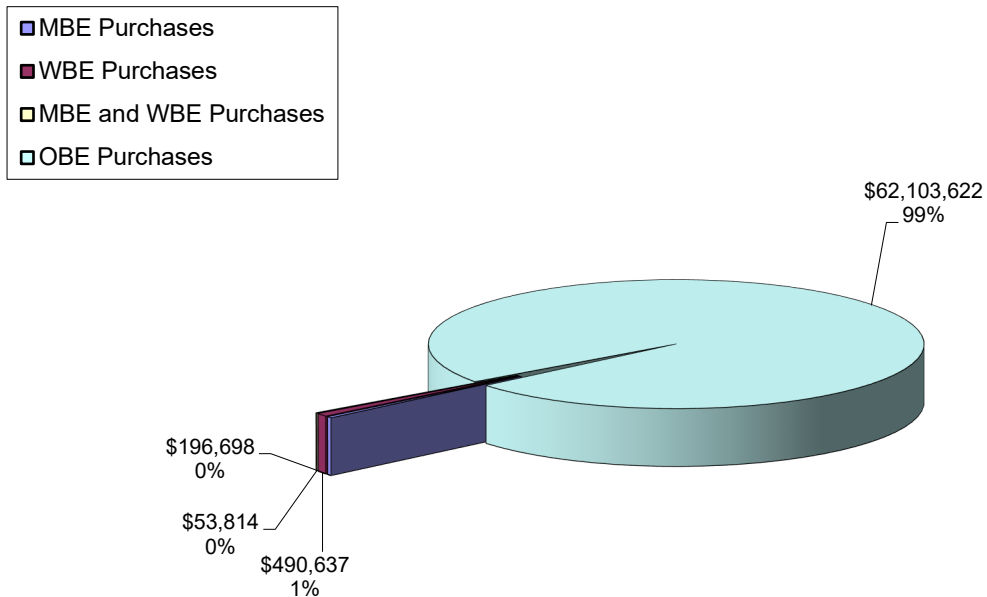
