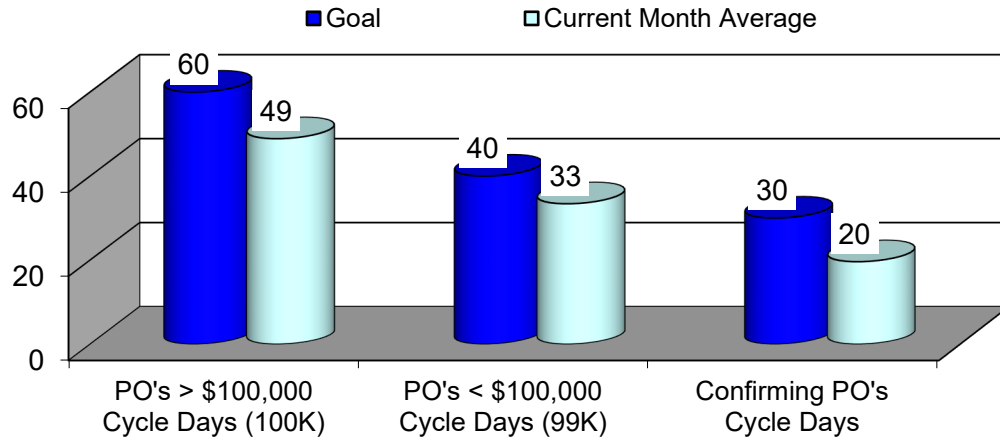




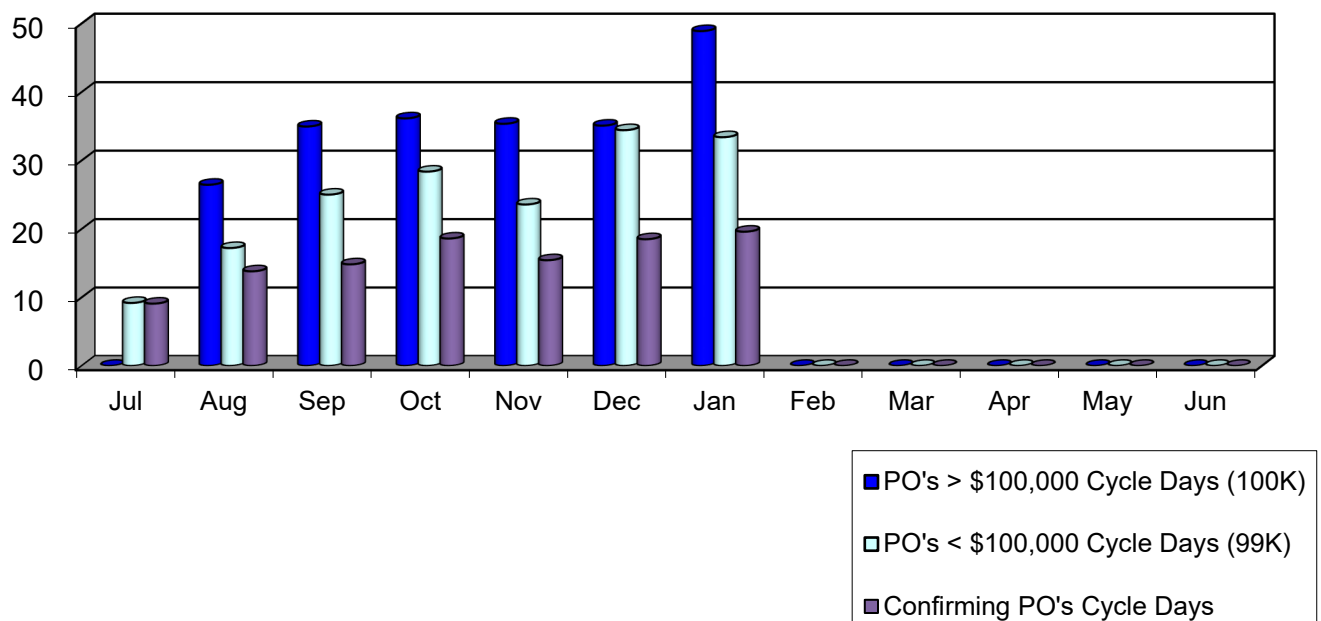




### Cycle Time for Requisitions Assigned to PO Award Current Month vs. Goal

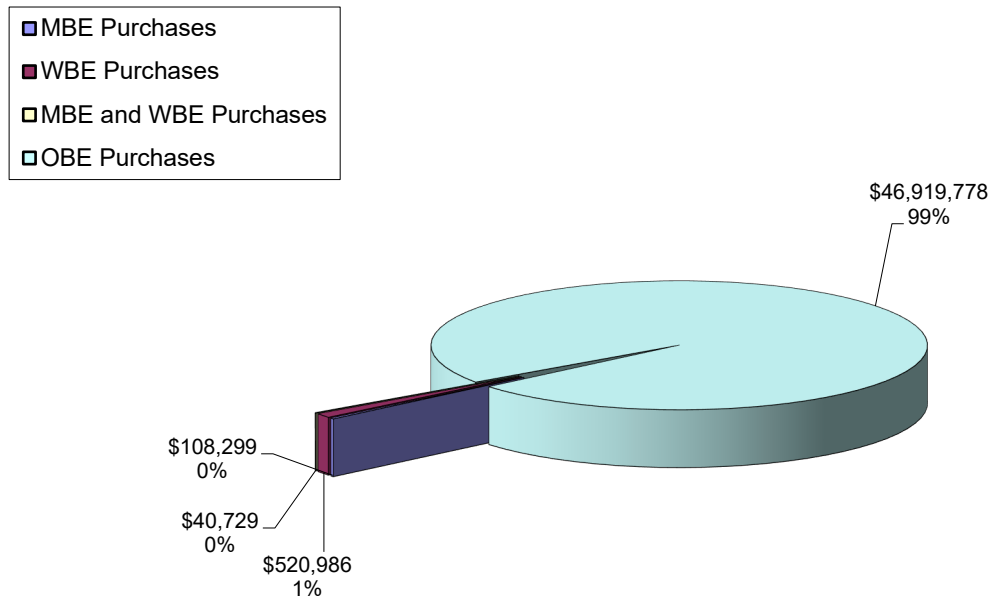


### Cycle Time for Requisitions Assigned to PO Award





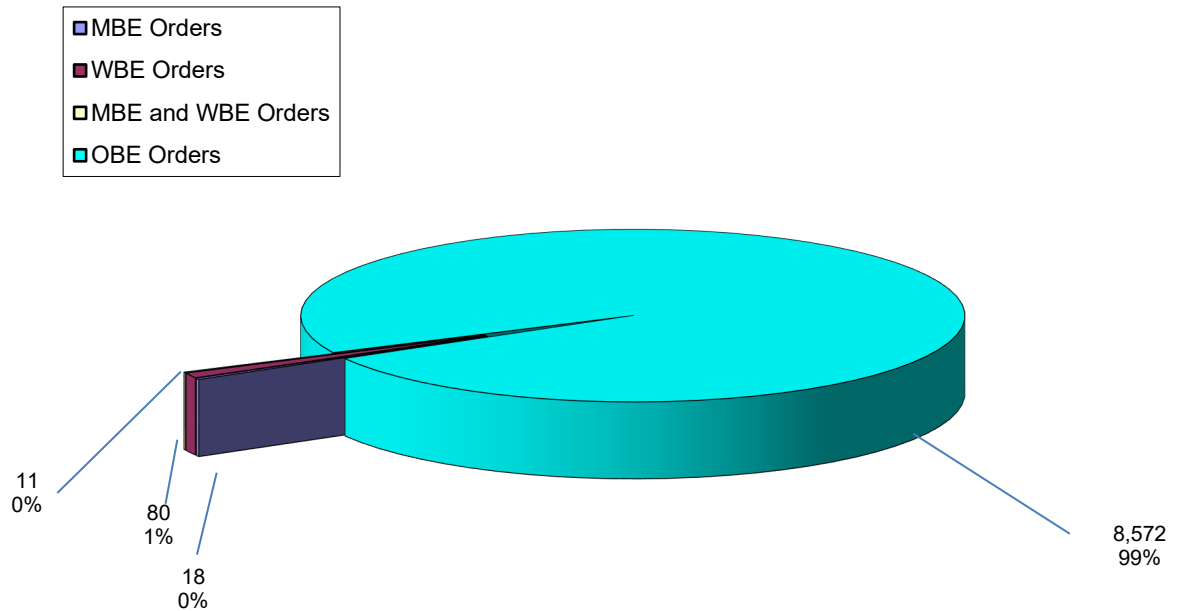

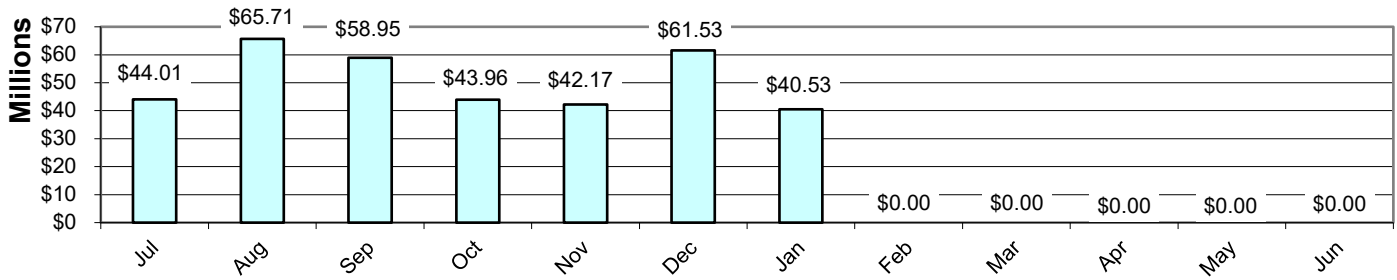
### Discounts Captured and Lost (Dollar Amounts)



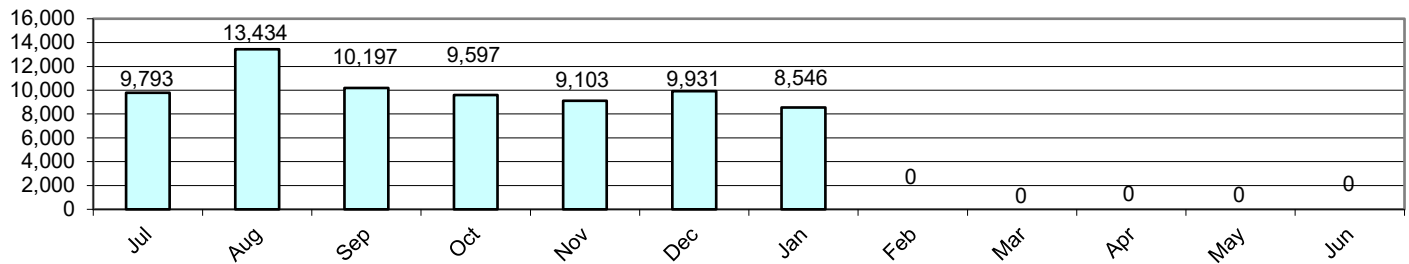

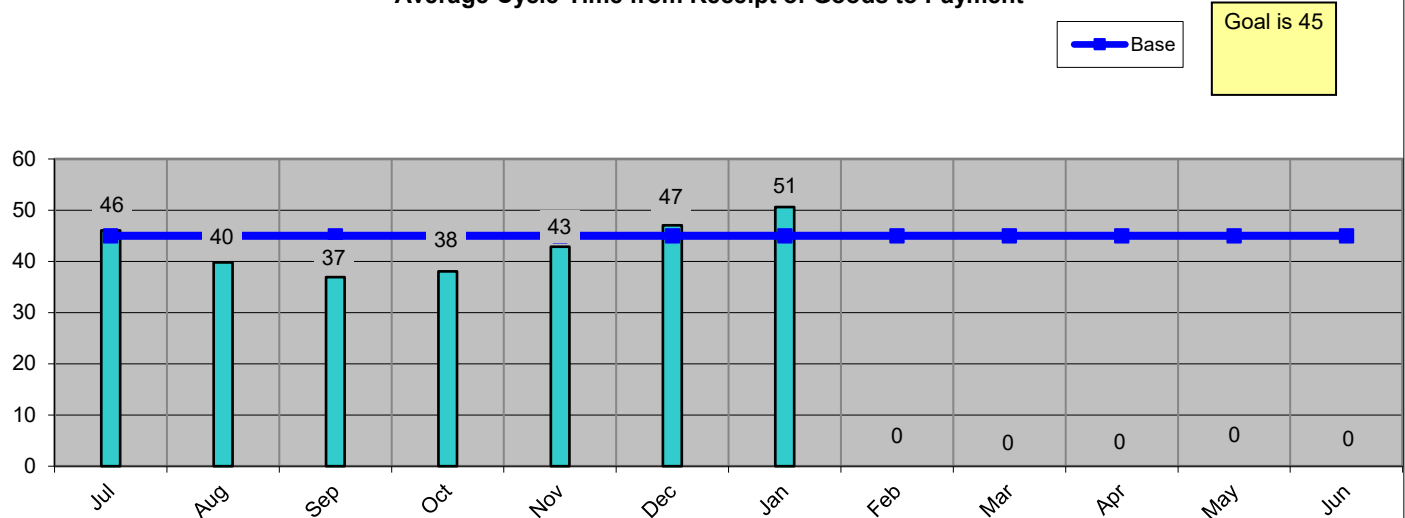
